The COVID-19 situation has placed us in unprecedented times. We want to assure you that Poclain strives to balance continuity and service to our customers with our civic compliance and care for our employees.

Recently, State governments have issued 'stay at home' orders or guidance. We have determined that we are exempt from these limitations as we support the food, agriculture, transportation and energy sectors which are designated as <u>essential critical infrastructure workers</u> by the Department of Homeland Security. Poclain Hydraulics continues to operate in the face of COVID-19 because our business, as designated by the President of the United States and the United States Department of Homeland Security, is essential to ensuring community and national resilience and wellbeing. Re: Ongoing US Operations

Dear Mr. McNeilly,

Please note that Tesla Inc. continues only its most critical operations in the United States under applicable state orders and federal guidance. Tesla's ongoing, scaled back operations fall within the following Critical Infrastructure Sectors as defined by the Department of Homeland Security: "vehicle manufacturing," "electric motor manufacturing," and the "energy sector." DHS specifically recognized that these areas are "more than 80 percent... owned by the private sector" and "uniquely critical" as they provide an "enabling function" across all critical infrastructure sectors. Accordingly, we believe that employees of Tesla and its suppliers may continue their work in only the most critical areas and with the public health precautions including the CDC guidelines on social distancing.

In California, our operations also fall within the purview of Critical Infrastructure, as that term is referenced in Governor Newsom's March 19, 2020 Executive Order (N-33-20). The Governor expressly adopted this exemption in N-33-20, which makes clear that all businesses involved in the nation's critical infrastructure sectors must be allowed to operate.<sup>3</sup> N-33-20 specifically provides:

Individuals may leave their home "...as needed to maintain continuity of operations of the federal critical infrastructure sectors, as outlined at <a href="https://www.cisa.gov/identifying-critical-infrastructure-during-covid-19">https://www.cisa.gov/identifying-critical-infrastructure-during-covid-19</a>.

The federal government has identified 16 critical infrastructure sectors whose assets, systems, and networsk, whether physical or virtual, are considered so vital to the United States that their incapacitation or destruction would have a debilitating effect on security, economic security, public health or safety, or any combination thereof....Californians working in these 16 critical infrastructure sectors may continue their work because of the importance of these sectors to Californians' health and well-being."

Accordingly, we believe that employees of Tesla and its suppliers may also continue their work under applicable state orders and the public health precautions including the CDC guidelines on social distancing.

Please let us know if you would like to discuss further, including if you have any questions about our continuing operations or if you interpret the applicable state orders and federal guidance differently. We will also be sharing with your team the enhanced safety and public health measures we have instituted at Tesla facilities throughout the United States. We have scaled back production to only the most critical operations as defined by federal and state authorities, and we remain able and willing to continue our business relationship with you during this time under the foregoing restrictions.

## Dear Supplier:

As you are aware, throughout the country, the federal, state and local governments are recommending or requiring measures to help stem the COVID-19 pandemic. Mazda Toyota Manufacturing (MTM) is doing its part, by directing team members and business partners who can work at home to do so and practicing social distancing and other recommended mitigation strategies where workers need to be onsite. We've also temporarily suspended production at our manufacturing facilities to conduct a thorough cleaning of the facilities to help promote the health and safety of our team members.

Under guidance issued by the Department of Homeland Security's (DHS's) Cybersecurity & Infrastructure Security Agency ("CISA"), Mazda Toyota Manufacturing qualifies as a critical infrastructure company. Quite simply, our work helps people have reliable personal transportation to conduct the essential daily activities of their lives, including going to work if they need to work on-site (e.g., at medical facilities, grocery stores, etc.), or to leave their residence for health and safety reasons, for necessary food and other supplies/services or to take care of others, etc.

CISA's guidance tells us: "If you work in a critical infrastructure industry, as defined by the Department of Homeland Security . . . you have a special responsibility to maintain your normal work schedule." And, we can't do our work without you – because you are a critical part of our supply chain, your work is equally critical.

We will be in contact with you to discuss planned work levels in light of anticipated decline in market demand related to the economic impact of the pandemic. In the meantime, please be sure to work closely with your Mazda Toyota Manufacturing team regarding potential impacts to your operations in these evolving times.

We have every confidence we'll get through these challenging times together and are here to support you in our efforts to ensure those that most need it have access to reliable transportation.

RE: Essential Business Manufacturing

## Dear Mark:

I understand that Michigan Governor Gretchen Whitmer issued Executive Order No. 2020-21 ordering statewide "Stay-At-Home" provisions between March 24, 2020 through April 30, 2020. It is also my understanding that Warfield Brewing Company, LLC's equipment manufacturing has been halted. In an effort to ensure that Warfield Brewing Company, LLC ("Warfield") can continue to operate as an essential business, I ask that Complete Automation restart manufacturing of Warfield's equipment.

Under Director Christopher C. Krebs's letter dated March 28, 2020 and titled, "Memorandum on Identification of Essential Critical Infrastructure Workers During Covid-19 Response," the Director states that certain critical manufacturing is considered essential. In particular, it states the following employees are considered essential:

Workers necessary for the manufacturing of metals (including steel and aluminum), industrial minerals, semiconductors, materials and products needed for medical supply chains, and for supply chains associated with transportation, energy, communications, information technology, food and agriculture, chemical manufacturing, nuclear facilities, wood products, commodities used as fuel for power generation facilities, the operation of dams, water and wastewater treatment, processing and reprocessing of solid waste, emergency services, and the defense industrial base. Additionally, workers needed to maintain the continuity of these manufacturing functions and associated supply chains, and workers necessary to maintain a manufacturing operation in warm standby.

In this situation, Warfield is an essential manufacturer of food products. Without Complete Automation's continued work on Warfield's tanks, Warfield will not be able to meet future demand for its food products. Therefore, Warfield asserts and requests that Complete Automation may and should continue manufacturing Warfield's brewing tanks as well as any other items incidental to Warfield's food production including production by any third-party vendor. Nevertheless, we believe Complete Automation is in the best position to keep its employees safe during this pandemic crisis; therefore, Warfield gives complete and sole authority to Complete Automation

to determine when and how to bring employees back to work in a safe and efficient manner to complete the tasks outlined in this letter.
